# **Grant Funds Available for Lead Pipe Removal in Childcare Facilities**



In September of 2020, Greater Cincinnati Water Works (GCWW) announced it had been awarded \$725,000 in state funding as part of Governor DeWine's H2Ohio Initiative to replace lead service lines in licensed childcare facilities


within the utility's service area.

Any ODJFS licensed childcare center with a lead service line in GCWW's service area is eligible to have a lead line removed at no cost to them. Grant funding is available to providers who rent or own the facility. ### **Summer IT Help Through University of Cincinnati**

<u>UC's Summer 2022 NEXT Wage Support Program</u> supports tech-based projects at nonprofits. The SERVE-IT part of the program will reimburse not-for-profit organizations for student wages at 100% for student employment up to 80 hours, not exceeding \$1000\*. For employment that exceeds 80 hours, the organization is expected to provide a 50% match. Not-for-

profits have the option of hiring more than one student for work assignments that exceed 80 hours in order to make the most of the funding and to give more students the opportunity to practice and refine their skills. For IT-related work that can

be performed remotely, the University of Cincinnati will provide on-campus workspace for students. Applications due February 28, 2022. More info here.

### Free Child ID App Helps Identify Children in Emergencies

Hamilton County Sheriff's Office District 5 is urging parents to take advantage of a free child ID app that stores vital information, including photos, of their children right on mobile devices.

The free app is called "FBI Child ID." The FBI Child ID app, the first mobile application created by the FBI, provides a convenient place to electronically store photos and other vital information about children so that it's literally right at hand when needed. Through the app, parents can show the pictures and provide physical identifiers such as height and weight to security or police officers on the spot. Using a special tab on the app, parents can also quickly and easily e-mail the information to authorities with a few clicks. More information is available here.

### **Community Health Needs Assessment Released**

The <u>2021 Regional Community Health Needs Assessment</u> recently was released. The report identifies the most pressing health needs in our region as well as top priorities such as investment in the workforce pipeline, diversity and health-related social needs such as housing and food.

The report also found that differences in health outcomes are most common among people of color and those with lower education, lower income or those without or with insufficient health insurance.

Ohio EPA Recycling and Litter Prevention Grants. The Ohio EPA's Recycling and Litter Prevention program offers large-scale, competitive grants to support communities, businesses and academic institutions that initiate or expand recycling programs, stimulate economic growth, and support litter prevention efforts. Open to local governments and nonprofits. Applications due February 11, 2022

**Covington Neighborhood Grant Program.** Have an idea to spruce up your neighborhood? The city of Covington started the Neighborhood Grant program to fund small, citizen-lead projects throughout the city. The deadline to apply is February 14, 2022. Hamilton County R3Source offers multiple grants ranging from easy, non-competitive grants to a larger, competitive grant available for communities, schools, nonprofit organizations and businesses. Competitive grant with proposals due February 15, 2022

**The Spirit of Construction Foundation** supports outreach initiatives that seek to engage young people in construction careers. Over the past 5 years (in addition to scholarship funding), the SOC Foundation has contributed over \$760,000 towards outreach and \$1.2 million since its founding. The initiatives have a construction component to them and are geared for the most part towards middle school and high school youth. Deadline Feb. 15, 2022.

**Andrew Jergens Foundation grant.** The Foundation's prime interest is the health, education, cultural experiences and social welfare of children in the Greater Cincinnati area. Deadline for submission is Feb. 15, 2022.

Hamilton County ARP Arts and Culture Relief Grants are currently being accepted for the \$2 million program, funded by the County's allocation of the American Rescue Plan (ARP) Act dollars to help the nonprofit arts community combat the ongoing financial impacts of COVID-19. Eligible nonprofit arts and culture organizations with a physical address in Hamilton County may apply for funding. Deadline to apply is February 15, 2022. at 5:00 p.m.

**Hamilton County R3Source** is offering multiple grants ranging from easy, non-competitive grants to a larger, competitive grant available for communities, schools, nonprofit organizations, and businesses. Grants include the R3Source Infrastructure Grant, the Waste Reduction Innovation Grant, Greater Cincinnati Smart Kitchen Initiative and Residential Recycling Incentive (RRI). Proposals are due February 15, 2022.

The bi3 Transforming Health in Greater Cincinnati Grant is seeking proposals from nonprofit organizations for planning, piloting or implementing projects that address system barriers and build health equity. Grants will be based on project proposals but could range from \$100,000 to \$3 million. bi3 will give priority to projects related to maternal and infanthealth, child and family resilience. Letters of intent are due Thursday, Feb. 17.
