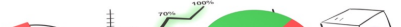

Starting to Plan for 2023 Budgeting Tips

It's October already, and time to start thinking about a budget for 2023. Here are some tips and considerations as you start your planning.

- Start early! Include other staff members in the process, especially if they will be responsible for staying within budget on line items.
- Instead of just using the past to calculate next year's budget, think about what new programs, people and other expenses will be needed to support your agency goals.
- Do you have a cash reserve? If not, you may not get to the ideal of 3-6 months of expenses, but you can plan for a start.
- Have you had some years with a positive bottom line? If you have an



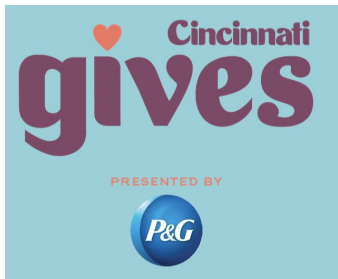
adequate cash reserve, is your board comfortable with spending some of that on future growth?

- In today's hiring environment, recognize the importance of professional development for staff retention. Budget for this and let your staff know that you want to invest in them!
- Do you need help beyond your staff's capabilities? Consider budgeting for support from OneSource Center's consulting staff. And if you need help with creating and managing a budget, we can help with that too!

The National Council of Nonprofits states "A key component of financial sustainability is the commitment of board and staff to financial management that includes timely review of financial reports and advance planning. Santa Maria's fall's health fair will include free COVID-19 vaccines from the Ohio Department of Health. **Caracole** will administer HIV and STD tests. The **St. Elizabeth** mammogram van will be offering free mammograms by appointment. There will be free health screenings, including blood pressure, plus glucose testing and Body Mass Index (BMI) calculations. **Talbert House** will be on hand with mental health and substance abuse prevention resources. The health fair will also include free food distribution, thanks to a partnership with the **Freestore Foodbank**, and a free hot meal to enjoy at the event.

Each year 6,000 students participate in the Magnified Giving Program. Students are entrusted with \$1,000.00 to grant to the 501c3 nonprofit of their choice. They serve organizations using their time, talent, and treasure. Ultimately, they become an advocate, leader, and philanthropist long after their time in the program.



Participating nonprofits educate students on your mission, impact, and how they can be involved with your organization now and in the future. Students are encouraged, but not required, to volunteer within the nonprofit they select. Student groups create PSA's, short videos, or presentations that are shared with their class, school, and community. Finally, should students select your non-profit, you may be eligible for a financial grant from the students through Magnified Giving.




















